ARTICLE I
NAME OF CORPORATION

The name of this corporation shall be INDEPENDENT
SOURCING, INC.

ARTICLE II
PRINCIPAL OFFICE

The principal office of this corporation shall be at:

ARTICLE III
DURATION

The corporation shall have perpetual existence unless sooner
dissolved according to law.

ARTICLE IV
PURPOSE

This corporation is organized for the following purposes:

- a) Distribution of components
- b) To purchase, improve, develop, lease, exchange, sell,
dispose of and otherwise deal in and turn to account, real
estate; buildings of every kind and character whatsoever; to

d) The transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

CAPITAL STOCK

The authorized capital stock of this corporation shall be one hundred (100) shares of Common Stock at One (\$1.00) Dollar par value.

ARTICLE VI

RELATIVE RIGHTS OF SHARES OF CAPITAL STOCK





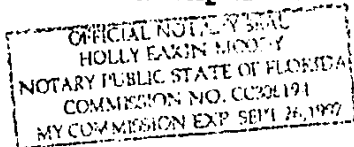
