We are in receipt of your August 23 letter indicating that the Articles of Revocation of Dissolution we submitted were not filed due to the expiration of 120-day time limit. I do have the following clarification points/questions with regard to this matter:

- 1. The information contained on your web site indicates that the revocation can be filed within 120 days of the EFFECTIVE date of the dissolution (in this case the effective date of the dissolution was May 15, 2002). However, the letter received today indicates they should have been filed 120 days from the date the Articles were FILED (in this case April 17, 2002). Please refer to Attachment I. In counting from the date of the filing, August 15, 2002 would have been 120 days. Our cover letter and revocation documents were signed on August 10, 2002. Although I do not have proof of the actual mailing date, it is clear the intent was to revoke the dissolution within the appropriate time period. And had the filing date been 120 days from the effective date of the dissolution, we would have been well within this timeframe.
- When the revocation was submitted, a check was enclosed for the appropriate amount for the filing fee and one certified copy of the revocation. If the documents arrived past the 120-day limit, why was the check not returned with the original documents?

I would like to request that you reconsider the validity of this filing given the conflicting information that I have presented, and the fact that the documents were signed and dated prior to the 120-day deadline. There was no substantiated proof provided that these documents did not arrive in your offices by the stated deadline. I believe that our intent to revoke the articles of dissolution was clear, and this matter is simply a misunderstanding and miscommunication of information.
