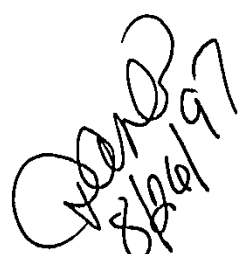

ARTICLES OF INCORPORATION  
OF  
LYNDA LONG, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is LYNDA LONG, INC., whose principal place of business is 2008 S.E. 26th Avenue, Ft. Lauderdale, Florida 33316.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purpose for the organization of the corporation is to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

The corporation shall have the authority to issue ten thousand (10,000) shares, all of one class of Common Stock, with a par value of \$1.00 per share.

#### **ARTICLE VIII**

The shareholders shall have the power to adopt, amend, alter, change, or repeal the Articles of Incorporation when proposed and approved at a stockholders meeting, with not less than a two-thirds vote of the common stock.

#### **ARTICLE IX**

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors.

#### **ARTICLE X**

The holders of the common stock of this corporation shall have preemptive rights to purchase, such shares of stock of this corporation as may be issued for money or any property or services, from time to time, and at prices, terms, and conditions that shall be fixed by the Board of Directors, in addition to that stock authorized by the corporation. The preemptive rights of any holder

are determined by the ratio of the authorized shares of common stock held by the holder to all shares of common stock currently authorized.

#### ARTICLE XI

Pursuant to Florida Statute Section 607.167(1), the effective date of the commencement of corporate existence is the 21st day of August, 1997, which is the date of subscription and acknowledgement of the Articles of Incorporation. Said Articles of Incorporation are to be filed within five (5) days after such date.

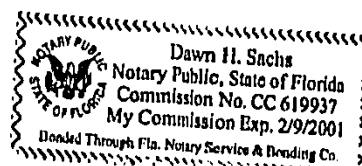

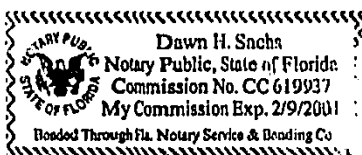
