The undersigned Incorporators for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be National Fire Extinguishers, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 2425 Spoonwood Drive, Tallahassee, Florida 32303.

ARTICLE III SHARES

The number of shares of stock that this corporation is authorized to have outstanding at any one time shall be three hundred (300) shares of common stock, all of which shares shall be fully paid and non-assessable. In the event these Articles of Incorporation are hereafter duly amended to authorize the issuance of additional shares of stock in the Corporation, then each stockholder, upon the sale for cash of any such additional stock of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof, at the price at which it is offered to others.

ARTICLE IV RESTRICTIONS ON TRANSFER

All shares of capital stock issued by this Corporation may be subject to certain restrictions on transfer which may from time to time be imposed by agreement of stockholders.

ARTICLE V INITIAL REGISTERED AGENT AND STREET ADDRESS

The name and Florida address of the initial registered agent are Lawrence Scoma, 2425 Spoonwood Dr., Tallahassee, Fl. 32303.

Having been named as registered agent and to accept service of process for the herein stated corporation at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent.
