ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

Name

The name of the corporation is VUU ENTERPRISES, INC.

ARTICLE II.

Address

The principal address of the corporation shall be 2801 34th St. S., St. Petersburg, FL 33711.

ARTICLE III.

Duration

The duration of the corporation is perpetual.

ARTICLE IV.

Purpose
