Article I

Name and Address of Corporation

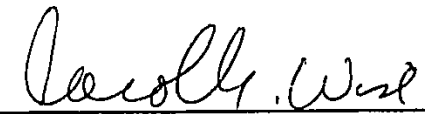

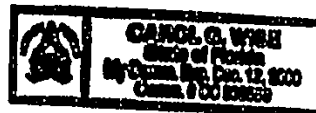
