

THE UNDERSIGNED, acting as sole incorporator of **The Patio Warehouse, Inc.**, under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be **The Patio Warehouse, Inc.**,

ARTICLE II

Shares

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

ARTICLE III

Principal Office

The address of the Principal Office of the corporation 12100 Sapphire Drive, Clermont, Florida 34711. The location of the Principal Office shall be subject to change as may be provided in bylaws duly adopted by the corporation.

The number of Directors constituting the initial Board of Directors of the corporation is two. ARTICLE VII



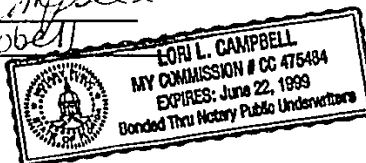
