ARTICLE I. NAME

The name of the corporation is David Dees P.A. *RECEIVED*

8-23-97

ARTICLE II. COMMENCEMENT AND DURATION

This corporation is to commence its corporate existence on the date of subscription and acknowledgment of these articles of incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of providing goods and services attendant to the practice of law.

ARTICLE IV. PRINCIPAL OFFICE

The address of the corporation's principal office shall be 3300 North Pace Boulevard, Suite 315, Pensacola, FL 32505, and the mailing address is Post Office Box 12602, Pensacola, FL 32574.

ARTICLE V. CAPITAL STOCK

This corporation is authorized to issue Seven Hundred Fifty (750) shares of Ten (\$10.00) Dollar par value common stock.

ARTICLE VI. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series, as that which he already holds, shall have the right to purchase his prorata

share (as nearly as may be done without issuance of fractional shares) at the price which it is offered to others.

ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VIII. INITIAL BOARD OF DIRECTORS

This corporation shall have one director initially. The number of directors may be increased or decreased from time to time as provided in the by-laws. However, the number of directors shall never be less than one.

ARTICLE X. RESTRICTIONS ON TRANSFER OF STOCK

Shares of capital stock of this corporation shall be issued initially through the following persons and in the amount set opposite their name:

Shares held by the initial shareholders listed above may not be resold or otherwise transferred to other persons unless first

offered to the remaining shareholders of this corporation. The price and terms at which, and the time within which those shares may be offered and sold shall be further specified by written agreement among all of the shareholders and this corporation.

ARTICLE XI. DIRECTORS

The directors of the corporation shall be voted upon for election once every year. The initial director shall be David L. Dees.

ARTICLE XII. REMOVAL OF DIRECTORS

The shareholders of this corporation shall not be entitled to remove any director from office during his term except for malfeasance in office.

ARTICLE XIII. DIRECTOR QUORUM AND VOTING

A majority of the directors shall constitute a quorum for a meeting of directors. If a quorum is present, the affirmative vote of a majority of the directors present, or if a director or directors have abstained from voting because of an interest in the matter to be voted upon, the affirmative vote of a majority of the directors present and voting shall be the act of the board of directors.

ARTICLE XIV. INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

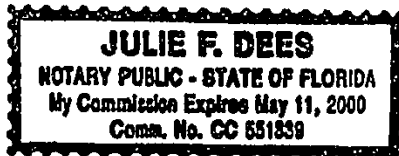
