- 7.5 The holders of the preferred shares shall be entitled to such rights, preferences, and restrictions as are determined by the Board of Directors prior to issue and duly filed with the Florida Department of State.
- 7.6 There will be no restriction on the per-share voting rights of the common shares and the holders thereof shall receive the net proceeds of the Corporation upon dissolution in proportion to their shareholdings. Preferred shares can only be voted with respect to matters specifically authorized in the set of rights subsequently determined by the Board prior to their issue. Holders of Preferred shares will possess only such claims on assets as are consistent with rights and preferences so authorized prior to any issue of the Preferred shares and after the satisfaction of any such claims, Preferred shares will not be counted or otherwise considered in the distribution of remaining net assets upon dissolution.

ARTICLE 8 - SHAREHOLDERS' RESTRICTIVE AGREEMENT

All of the shares of stock of this Corporation may be subject to a Shareholders' Restrictive Agreement containing numerous restrictions on the rights of shareholders of the Corporation and transferability of the shares of stock of the Corporation. ARTICLE 9 - POWERS OF CORPORATION
