1. Name.

The name of the Corporation is set forth above.

2. Principal Office and Registered Agent.

Its registered office and principal office in the State of Florida is 7500 Ulmerton Road, #30, Largo, Florida 33771. The name of its registered agent at such address is Fran Talaga.

3. Purposes.
