ARTICLES OF INCORPORATION

OF

NEXT STEP UNLIMITED, INC.

The undersigned acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of this corporation is NEXT STEP UNLIMITED, INC.

ARTICLE II

DURATION

This corporation shall exist perpetually, commencing upon the filing of these Articles with the Florida Secretary of State.

ARTICLE III

PURPOSE

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.
