**ARTICLE I - NAME.**

The name of this corporation is **FREEBEE CORPORATION**

**ARTICLE II - DURATION.**

---

This corporation is to have perpetual existence beginning with the date of subscription and acknowledgment of these Articles of Incorporation which is August 25, 1997.

**ARTICLE III - PURPOSE.**

---

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States of America and of the State of Florida.

**ARTICLE IV - CAPITAL STOCK.**

This corporation is authorized to issue 1,000 shares of common stock at \$1.00 par value per share.

#### **ARTICLE V - PREEMPTIVE RIGHTS.**


