THE UNDERSIGNED, acting as joint incorporators of a corporation to be formed under the Florida General Corporation Act, adopts the following Articles of Incorporation with an effective date of September 1, 1997:

ARTICLE I

The name of the Corporation (hereinafter, the "Corporation") is Parker Financial Services, Inc. whose principal office is 3078 North Tamiami Trail, Suite #200, Naples, Florida 34103.

ARTICLE II

The purpose of purposes for which the corporation is organized are:

To engage in the transaction of any or all lawful business of which corporations may be incorporated under the provisions of the Florida General Corporation Act.

ARTICLE III

The aggregate number of shares which the Corporation shall have authority to issue is Ten Thousand (10,000) shares of common stock, and the par value of each such share is One Dollar (\$1.00), amounting to the aggregate of Ten Thousand Dollars and No/100 Cents (\$10,000.00).

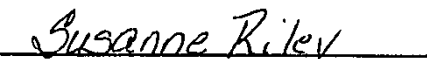
