The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

EFFECTIVE DATE

NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is East Nursery, Inc.

ARTICLE II

DURATION

Section 2.1 <u>Duration</u>. This corporation shall exist perpetually. ARTICLE III

PURPOSES

CAPITAL
