



5. This merger shall become effective on the date that it is filed with the Department of State of the State of Florida.




THE PARTIES to this Plan of Merger are CDC INTERNATIONAL CORP. ("CDC INTERNATIONAL"), and EXPRESS PAPER COMPANY, INC. ("EXPRESS PAPER") and SOUTH FLORIDA TISSUE PAPER (SOFT) COMPANY ("SOUTH FLORIDA"). All three corporations are organized under the laws of the State of Florida, and certify that they have enacted the following Plan of Merger.

- A. CDC INTERNATIONAL, EXPRESS PAPER, AND SOUTH FLORIDA, shall be merged into one (1) Florida Corporation. The surviving entity shall be SOUTH FLORIDA.
- B. After the effective date of this merger, the Articles of Corporation of SOUTH FLORIDA shall be unchanged.
- C. The assets and liabilities of CDC INTERNATIONAL and EXPRESS PAPER are merged into and assumed by SOUTH FLORIDA as a result of this merger.
- D. The three corporations involved in this merger, have the same shareholder. Therefore, all of the outstanding and issued stock of CDC INTERNATIONAL and EXPRESS PAPER shall be cancelled, and the issued and outstanding stock of SOUTH FLORIDA continues to be in force. These SOUTH FLORIDA shares represent all of the capital stock of the surviving corporation.
- E. The attorney for this corporation shall cause Articles of Merger to be prepared consistent with this plan, and have the Articles filed with the Department of State, State of Florida, at which time, the merger shall become effective. A copy of this Plan shall be part of the permanent records of CDC INTERNATIONAL, EXPRESS PAPER, and SOUTH FLORIDA, and shall be kept in the offices of SOUTH FLORIDA, the surviving corporation.
