#### ARTICLES OF INCORPORATION

We, the undersigned, hereby agree to become associated together and do hereby associate ourselves FILED together for the purpose of incorporating under the Florida General Corporation Act, including any and 26 PN 3: 55 all amendments thereto, the provisions of which are accepted and we do hereby certify as follows:
