**ARTICLES OF INCORPORATION
OF

The undersigned, acting as the incorporator of St. L. B. of Florida, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is:

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III. INITIAL BOARD OF DIRECTORS
