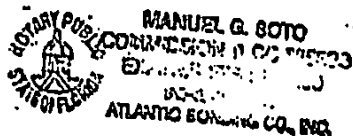
ARTICLE XIV



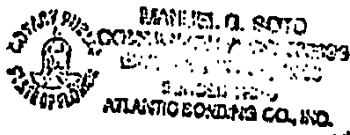

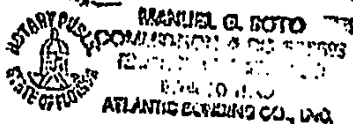
