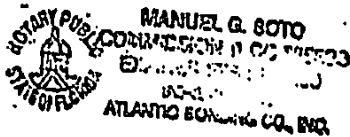
ARTICLE XIV



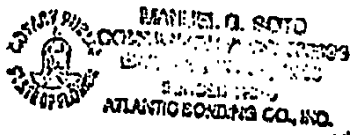

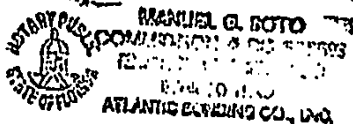
