OF

the undersigned incorporator makes, subscribes, acknowledges the files with the Department of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation is:

Terms of Existence

Nature of Business

Capital Structure

The maximum number of share of stock that this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock, having a par value of \$.10 per share. Each of the said share of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in cash, in property or in labor and services at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be paid for and shall be non-assessable.

ARTICLE V

Initial Registered Agent and Registered Office

The initial registered agent of this corporation shall be Rob W. Howland. 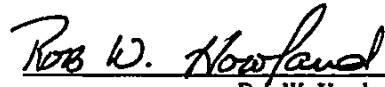
