The shareholders of this corporation shall be, and are hereby vested with, preemptive rights as to their shareholdings in this corporation.



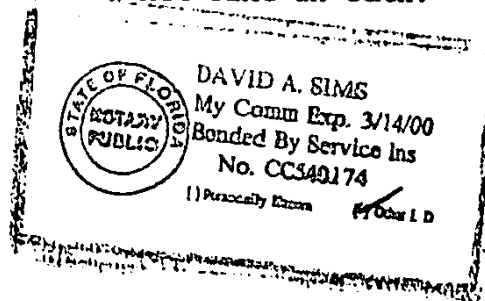
