ARTICLES OF INCORPORATION OF EXOCET CORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person to competent to contract, hereby forms a corporation under the laws of the State of Florida, by and under the provisions for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I - NAME

The name of the corporation shall be:

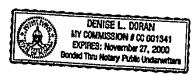
