The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, by and under the provisions for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I - NAME

The name of the corporation shall be:

EXOCET CORPORATION

ARTICLE II - BUSINESS AND POWERS

The general nature of the business proposed to be transacted and carried on, and the objectives, powers and purposes of the corporation, are to: (1) engage in any business or businesses (as may now or hereafter be lawful); (2) to have rights and powers (as may now or hereafter be lawful); and (3) to have such purposes and authorized under the laws of the State of Florida (as may now or hereafter be lawful).

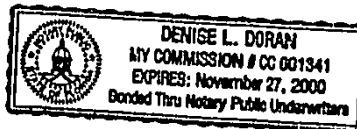
