ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

CENTER FOR RADIATION ONCOLOGY OF ZEPHYRHILLS, INC.

Pursuant to the provisions of Section 607.1006(1) of the Florida Business Corporation Act (the "Business Act") and Section 621 of the Florida Professional Service Corporation and Limited Liability Company Act (the "PA Act"), due to the future intent to merge this corporation into a Florida corporation formed under the PA Act which, pursuant to the provisions of Section 621.13(3) of the PA Act, requires that both corporations be operated under the PA Act, the undersigned Corporation, in order to bring itself under the provisions of Chapter 621 of the PA Act, hereby adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the Corporation is **CENTER FOR RADIATION ONCOLOGY OF ZEPHYRHILLS, INC.**

2. The following amendments to the Articles of Incorporation were adopted by the Shareholders and Directors of the Corporation on the 22 day of February, 2001, in the manner prescribed by the Florida Business Corporation Act:

(a) Article I is hereby amended in order to change the corporation name to "**CENTER FOR RADIATION ONCOLOGY OF ZEPHYRHILLS, P.A.**"

(b) The following new Article V is hereby added to the Articles of Incorporation:

"Article V - Nature of Business

The Corporation is organized as a Professional Service Corporation as permitted under the Florida Statutes and the Corporation will be engaged in every aspect of the business of rendering professional services to the public that a physician, duly licensed under the laws of the State of Florida, is authorized to render."

(c) The undersigned Corporation hereby agrees to the removal of itself from Chapter 607, as applicable, of the Business Act and agrees to be governed under the provisions of Section 621 of the PA Act.

3. The number of votes cast for the amendment by the Shareholders was sufficient for approval.
