#### ARTICLE I

#### **Name**

The name of the corporation is AMERICAN DIGITAL NETWORKS, INC.

### **ARTICLE II**

## **Amendment**

Article III of the Articles of Incorporation shall be amended to read as follows:

#### Shares .

The maximum number of shares of stock which the corporation is authorized to issue and have outstanding at any time shall be Twenty-Five Thousand (25,000) shares of Common A voting stock, One Cent (\$0.01) par value per share and Twenty-Five Thousand (25,000) shares of Common B non-voting stock, One Cent (\$0.01) par value per share. The rights and preferences of the shares shall be identical except that the holders of shares of Common A voting stock shall be entitled to one (1) vote per share on all matters submitted to a vote of the shareholders of the Corporation and the holders of shares of Common B non-voting stock shall not have voting rights.
