ARTICLES OF INCORPORATION

OF

A & R OF FORT WALTON, INC.

The undersigned, acting as incorporator of a corporation under the Laws of the State of Florida, adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is A & R of Fort Walton, Inc.

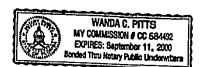
