Cho, March & Sonkin IPA, Inc., a independent practice association organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:

1. The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on August 27, 1997, under the name of Cho, March & Sonkin IPA, Inc., document number P97000074565.
2. The Amendment to the existing Articles of Incorporation being affected hereby is that resulting from completely deleting Article I of the Article of Incorporation as of the date hereof, and substituting in its place and stead the Article set forth below.
3. As amended below, Article I of the Articles of Incorporation has the sole effect of changing the Corporation's name from Cho, March & Sonkin IPA, Inc. to Cho, March & Latortue IPA, Inc..
4. This Amendment to the Articles of Incorporation was approved by unanimous joint written consent of the stockholders and Board of Directors of the Corporation, adopted on the 1st day of Oct., 1998.
5. These Articles of Amendment of the Articles of Incorporation shall be effective immediately upon filing by the Secretary of State of the State of Florida, all required taxes and fees having been paid, and thereafter, the name of the Corporation shall be "Cho, March & Latortue IPA, Inc." and Article I of the Articles of Incorporation of the Corporation shall read as follows:

ARTICLE I

Name

The name of this Corporation shall be:

CHO, MARCH & LATORTUE IPA, INC.
