The undersigned subscribers to these Articles of Incorporation competent to contract, hereby form a Corporation under Florida Statutes Chapter 607 and adopt the following as articles:

ARTICLE I

Name: The name of this Corporation is:

ARTICLE II

ARTICLE III

DURATION: The duration of the Corporation shall commence with the filing of Articles and continue perpetually.

ARTICLE IV

INCORPORATOR: The name and address of the person signing these Articles of Incorporation is: Dennis R. Long, 1313 E. Louise Ave., Tampa, Fl. 33603.

ARTICLE V

CAPITAL STOCK: This Corporation is authorized to issue One Thousand (1,000) shares of One-half Dollar (\$0.50) par value stock.

ARTICLE VI

PURPOSE: This Corporation may engage in any activity or business permitted under the laws of

the United States of American and of this State.

#### ARTICLE VII

**ORGANIZATION'S POWER TO ACQUIRE ASSETS:** Organization shall have the power to acquire assets and incur liabilities (real estate, buildings, equipment, and other investments) to which the majority of the shareholders shall control.

#### ARTICLE VIII

The name of the Corporation's initial registered agent in Florida is Dennis R. Long, 1313 Louise Ave., Tampa, Fl. 33603. The Registered Agent must state that he is familiar with and accepts the duties and responsibilities as Registered Agent for said Corporation.

#### ARTICLE IX

**INITIAL BOARD OF DIRECTORS:** This Corporation shall have two (2) director(s) initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws, but shall never be less than one. The name and address of the initial director(s) is/are Dennis R. Long, 1313 Louise Ave., Tampa, Fl. 33603; Robert J. Cambensy, Jr., 6912 Jones Rd., Odessa, Fl. 33556.

#### ARTICLE X

**AMENDMENT:** This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

#### ARTICLE XI

**BYLAWS:** The initial Bylaws shall be adopted by the Board of Directors. The power to alter, amend, or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the shareholders.


#### ARTICLE XII

**PREEMPTIVE RIGHTS:** The Corporation elects to have preemptive rights for the shareholders of this Corporation. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the Corporation stating the prices, terms and conditions of the issue of shares and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the Corporation within thirty (30) days of receipt of notice from the Corporation.

ARTICLE XIII

SHAREHOLDER VOTING: Shareholder voting and the type of shares issued shall be described in more detail in the corporate bylaws.




