**ARTICLES OF INCORPORATION OF
R.J. COMMERCIAL GROUP, INC.**

THE UNDERSIGNED, acting as sole incorporator of **R.J. COMMERCIAL GROUP, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is R.J. COMMERCIAL GROUP, INC.

Initial Board of Directors

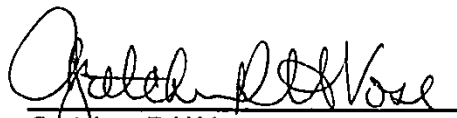
The corporation shall have two directors who shall manage the corporation. The initial board of directors shall be Rodney Perreault and John Maguire.

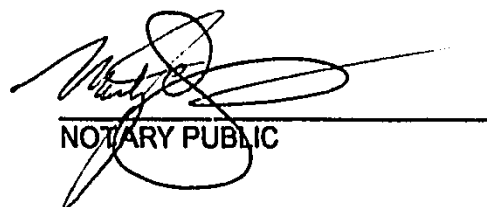

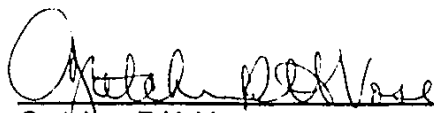
