Dear Mr. Caldwell,

As per our telephone conversation on 1/29/1999, I am sending you the 1998 / 1999 Profit Corporate Annual Report package. I have indicated that this report is for 1998 and 1999, as per your direction, and have enclosed two checks in the amount of \$150 to cover associated fees for 1998 and 1999.

To remind you of the circumstances which led to this late filing, MaggyLou Enterprises was formed end of 1997 in response to a need to process 1099 contracts. At that time, I anticipated several 1099 contracts in South Florida, which did not materialize. At the same time, I received an offer to go to Seattle, WA to work at The Boeing Company. This contract was not a 1099 contract. MaggyLou Enterprises did not make any money in 1997. Since the contract in Seattle, I've moved to contract work in Chicago, IL - none of which have been 1099 contracts. MaggyLou Enterprises did not make any money in 1998. This has been reported to the IRS.

I'd arranged with the person who is taking care of my property to immediately forward any information which came to my attention regarding MaggyLou Enterprises. Unfortunately, I must not have communicated the urgency of receiving these mailings. I received a box of mail for MaggyLou Enterprises the week of January 17. Included in this mailing were many communications from the IRS, and the Florida Department of State Division of Corporations. This is what prompted my phone calls to resolve the situation with the IRS, and with the Florida Department of State.

I realize that the responsibility for filing these papers is ultimately mine. However, I truly did not know they needed to be filed. I assure you that I have put some safeguards in place to assure that communication is forwarded to me in Chicago in a timely fashion. And, learning from this experience, I know what papers need to be filed and their associated deadlines. I am therefore appealing to have my late fee for filing waived to \$150 for 1998, and \$150 for 1999.

Thank you for your good advice on the phone. I truly appreciate your time, effort and intervention on rpy behalf.
