**ARTICLES OF INCORPORATION
OF
International Travelers Assistance Services, Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the laws of Florida, adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is: **International Travelers Assistance Services, Inc**

The purpose of the corporation is to undertake any business lawfully permitted to it, including, but not limited to, the sale of pre paid health coverage through airline tickets.

ARTICLE II

MAILING ADDRESS

ARTICLE III

CAPITAL STOCK

The number of shares of stock that the corporation is authorized to issue is One Thousand (1,000) shares, \$1.00 par value per share, of common stock. 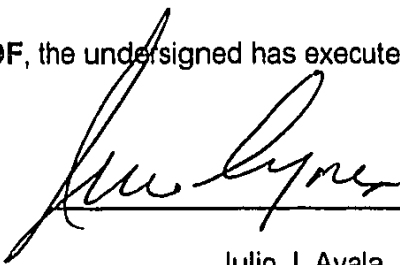
