In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is **D & D ENTERPRISES OF SOUTHWEST FLORIDA, INC.**

ARTICLE II

The existence of the corporation shall begin on August 25, 1997 and be perpetual.

ARTICLE III

The street address of the principal office of the Corporation is **16154 Cranston Avenue, Port Charlotte, Florida 33953.**

ARTICLE IV
