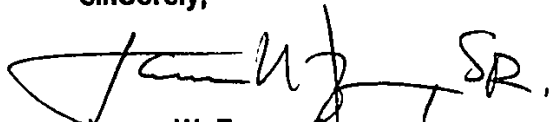

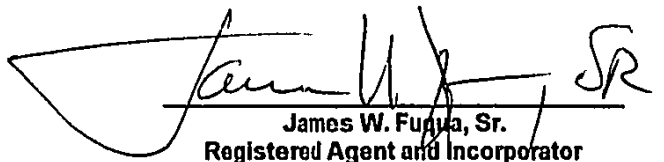
#### ARTICLE VIII. AMENDMENT OF ARTICLES
