ARTICLES OF INCORPORATION

OF

JEC ASSOCIATES II, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I · NAME

The name of the corporation is: JEC Associates II, Inc.
