## ARTICLES OF INCORPORATION

OF

#### ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is DINO'S AND NINO'S ITALIAN RESTAURANT & CLUB CORP. and its principal place of business shall be located at 912 - 71st Street, Miami, Beach, Florida 33141.

#### **ARTICLE II - DURATION**
