THE UNDERSIGNED, acting as incorporators of a corporation, adopt the following Articles of Incorporation for such corporation:

- 1. The name of the corporation is ACME Cleaning and Cutting Services, Inc.
- 2. The period of duration of the corporation is perpetual.
- 3. The purpose or purposes for which the corporation is organized are to engage in commercial cleaning, commercial and residential pressure washing, and lawn care, and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the state of Florida. In addition to the stated purpose, the corporation is authorized to conduct all lawful business activity in the state and outside.
- 4. Authorized Shares.

No classes of stock. The shares of the corporation are not to be divided into classes.

- 10. The shareholders shall have the power to adopt, amend, alter, change, or repeal the articles of the incorporation when proposed and approved at a stockholders meeting with not less than a unanimous vote on the common stock.
- 11. The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms, and conditions that shall be fixed by the Board of Directors, such shares of stock of this corporation as may be issued for money, property, or services from time to time, in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder to all shares of common stock currently authorized and issued.
- 12. The shareholders of this corporation shall be allowed to vote their shares cumulatively so as to give one candidate as many votes as the number of directors to be elected multiplied by the number of their shares, to distribute them among as many candidates as they may with. Notice must be given by any shareholder to the President or a Vice President of said corporation not less than 24 hours prior to the time set for the holding of a shareholders' meeting for the election of the directors that said shareholder intends to cumulate his vote at said election.
