The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be Dennis Robinson, Inc. The current corporate address of this corporation is 2090 River Reach Drive, #35, Naples, FL 34104.

ARTICLE II. DURATION

This corporation shall exist perpetually.

ARTICLE III. GENERAL PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of a notice from the corporation.

All shares of stock shall be entitled to cumulative voting in the election of the Board of Directors.

ARTICLE XII. EFFECTIVE DATE

The effective date of this corporation shall be August 1, 1997.
