RICHARD GRAVES ELECTRICAL CONTRACTING, INC.

THE UNDERSIGNED INCORPORATOR OF THESE ARTICLES OF INCORPORATION IS A NATURAL PERSON COMPETENT TO CONTRACT AND SELECTION HEREBY FORMS A CORPORATION FOR PROFIT UNDER THE GENERAL TO CORPORATION ACT AND OTHER LAWS OF THE STATE OF FLORIDA.

ARTICLE I. NAME

THE NAME OF THIS CORPORATION IS RICHARD GRAVES ELECTRICAL CONTRACTING, INC.

ARTICLE II. COMMENCEMENT

THIS CORPORATION WILL EXIST EFFECTIVE SEPTEMBER 1, 1997.
