ARTICLE V - REGISTERED AGENT



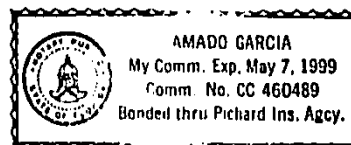
