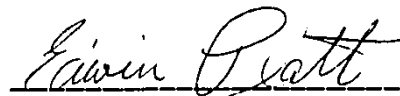
ARTICLE IX: AMENDMENTS

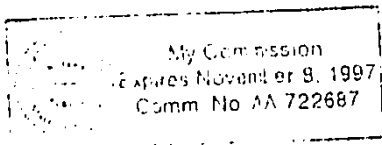

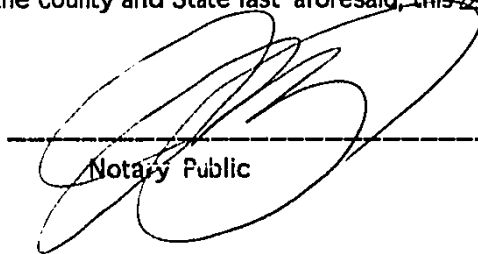
