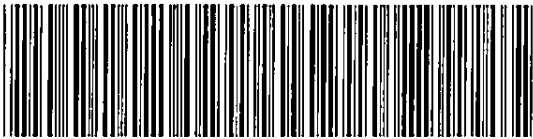


WHEREAS, MARY PAT STUBBS, died on February 2, 2024, owning assets in the State of Florida, and

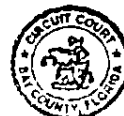




