**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of SILA HOLDINGS LIMITED, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is SILA HOLDINGS LIMITED, INC.

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE


ARTICLE VIII. BYLAWS
