ARTICLES OF INCORPORATION
FOR

AERO SPEC PAINT & FINISH, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is Aero Spec Paint & Finish, Inc.

ARTICLE TWO

The duration of the corporation is perpetual.

The general purposes for which the corporation is organized are:

1. To own and operate a paint and metal finishing business.




