The undersigned acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I. - NAME**

The name of the corporation is MARY FRANCES RUST, P.A.

**ARTICLE II. - PRINCIPAL OFFICE**

The street address of the principal office of this corporation is 458 Devil's Lane, Naples, Florida 34103.

**ARTICLE III. - PURPOSE**

The corporation is organized for the purpose of transacting real estate sales services within the State of Florida pursuant to Chapter 621, Florida Statutes, as now exist or may hereafter be amended.

**ARTICLE IV. CAPITAL STOCK**

This corporation is authorized to issue 1,000 shares of common stock with a par value of \$1.00 per share.

**ARTICLE V. PREEMPTIVE RIGHTS**
