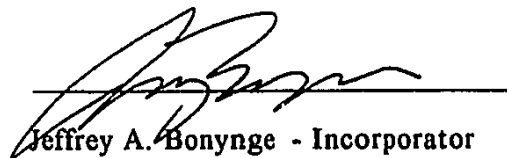
Article IX - Initial Officer

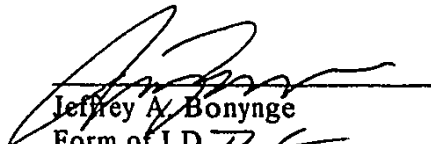

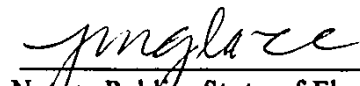

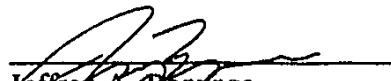
