First off I would to state that I have never been late with my payment in the past. My husband James O'Malley work out of town all week every week and counts on me to make these payments.

I will try to make this short. My mother is a six year cancer patient in the final stages of breast cancer, my two sisters live out of state and I am the only one given.

Starting about February, she thought she lost her purse only to find out it was stolen, when in three week after, and after consulting all her credit cards and bank accounts her house was broke into and all her drugs, purse and jewelry were stolen again (CASE #01-9459 NEW PORT RICHEY, Florida, Pasco Co.) Again after just receiving all new checks and credit cards we had to do it all over again.

Then in about 3-4 weeks, while at her doctor receiving chemo, her car was stolen (CASE #01-15091 NEW PORT RICHEY, FL). She that day moved in with me, since she was not safe at her home.

While living at our home and looking for

on a mental living facility, the man that rented her house committed suicide and was there for five to seven days the Sheriff's office thinks. (I don't have that case number but the officer in charge was Corporal D. Nottali of the Placer County Sheriff's office 727-847-5878). We had to call the Bio-hazard team to clean up and it was not cheap.

We have since got mom moved into an A.L.F. and sold her house. Her health is not good but she is safe.

These were only the large things that were going on at the time that caused me to get this V.B.R. away and I forgot about it. You can verify any of these things you like, but if you could waive this fee I sure would appreciate it.
