ARTICLES OF INCORPORATION OF

ARTICLE I - Name

The name of the corporation is: Sarasota Trucking Inc.

ARTICLE II - Existence

This corporation shall commence existence September 1, 1997.

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

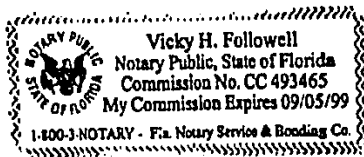
