ARTICLES OF INCORPORATION

OF

AUTO SHOWCASE, INC.

ARTICLE I

<u>Name</u>

The name of the corporation shall be AUTO SHOWCASE, INC.

ARTICLE II

Duration

This corporation shall exist perpetually.

ARTICLE IV


Capital Stock
