## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Law, adopts the following Articles of incorporation for such corporation.

1. Name & Address. The name of this corporation is Destiny Management Corporation and the address of the corporation is 1205 Curlew Road, Dunedin, Florida 34698.
2. Duration. The period of its duration is perpetual.
3. Purpose. The purpose is to engage in any activities or business permitted under the laws of the United States and the State of Florida.
4. Capital Stock. The corporation is authorized to issue 1000 shares, all of one class, at \$1.00 par value.
