

ARTICLE I -- NAME

The name of this corporation shall be SJS ENTERPRISES, INC..

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III -- PURPOSE

This corporation is organized to engage in any activity of business permitted under the laws of the United States or of this State.

ARTICLE IV -- TERM OF EXISTENCE

ARTICLE V -- CAPITAL STOCK
